Donations that meet Federal contribution law requirements are deposited to the 11CD Federal account; contributions that do not meet Federal requirements, but meet State requirements, are deposited to the 11CD non-Federal account.

For our Federal account, we only accept contributions from individuals or Federal PACs. Federal law prohibits contributions to the 11CD from the funds of corporations, labor organizations or national banks (including corporate or other business entity credit cards); any person contributing another person's funds; foreign nationals who lack permanent resident status; and government contractors.

Contributions from foreign nationals are strictly prohibited. Any information that you provide becomes a matter of public record and may be published. However, the 11CD respects the privacy of its donors, and discloses only the information that is required by law or regulation.
